TAP had been replaced Community Grants, Crowdfund Devon and Making the Connection, as sources for grants.

The Libraries summer reading challenge has successfully, book loans increased by 4%.

Amendments to parking restrictions at the Green Lane, Wrangaton junction could now proceed as the duplicated National Cycle Network route 2 along the A3121 has been removed.

The planned resurfacing of highways has been paused in order to deal with the pothole repairs.

84/19 Flooding from highways water run-off at "The First and Last Bistro" car park. Awaiting the outcome of the work being carried out by South West Water to ascertain if it will resolve the problem.

84/19 Ideas to restrict the width of the road near "The First and Last Bistro" to see if it would slow down traffic. **The area is within a 20 mph zone, no further ideas identified.**

84/19 Blocked drains on the left-hand side of Town Hill and Chapel Street. Grate to be removed to assess the situation. **Ongoing**

84/19 River Erme erosion A3121 - aerial survey is due this year. When completed an assessment of movement of riverbank will be confirmed. **Ongoing**

84/19 Playing field application to be a Village Green. Cllr Hosking has made an enquiry to the Devon County Council Solicitor and she has not made a decision. **Ongoing**

93/19 Flooding Westlake - being assessed by Cllr Hosking & DCC Highways. Ongoing

102/19 REPORT FROM DISTRICT COUNCILLOR TOM HOLWAY, INCLUDING OUTSTANDING ITEMS FROM PAST MEETINGS

Cllr Holway reported on the following: Plymouth schools admissions consultation

SHDC heating & insulation grants

Climate Change Working Group Meeting to take place on 5 December 2019.

No update at present in connection with Erme House issues raised by parishioners.

Locality money has been assigned to Ermington School for a camera and there is money available for organising the Village Fun Day.

85/19 Reinstatement of path around the playing field owned by SHDC by the river. Still being pursued.

85/19 Industrial Units – light pollution, may be practical to install alternative lighting. PSI has not been done and the lights are remaining switched on. **Still being pursued.**

86/19 Parishioner – height of hedge on the Ivybridge road bordering "The Spires" is above the South Hams District Council's 2.5 metres height planning stipulation. SHDC Enforcement Department are writing to appropriate householders in "The Spires".

103/19 QUESTIONS AND COMMENTS FROM MEMBERS OF THE PUBLIC TO THE PARISH COUNCIL, COUNTY & DISTRICT COUNCILLORS AND POLICE (A PERIOD OF NOT MORE THAN 15 MINUTES)

Cllr Walding – there have been a lot of comments on social media about environment issues in connection with the proposed gas plant planning application within the parish. Cllr Holway was aware of the planning application, but needed time to read the information before he would comment.

Parishioner pointed out during the recent wet weather there has been a constant puddle opposite the thatched cottage on the A379 (driving from Ermington to Yealmpton). Cllr Hosking asked for issues to be reported on https://www.devon.gov.uk/roadsandtransport/report-a-problem/

Also, the drainage work on the road from Ermington to Sheepham is not effective when it rains. Cllr Hosking will discuss with Nick Colton DCC Highways. **ACTION: Cllr Hosking.**

Amanda Burden from Luscombe Maye described the work which is being applied for in connection with planning reference: 2760/19/LBC - the proposal is for repairs to a listed building consent, alteration and extension of farmhouse, conversion and conservation of traditional stone barns into 3 no. residential dwellings with landscaping and wildlife enhancement at Strashleigh Farm, Ivybridge, PL21 9JP. Cllr Onley thanked Mrs Burden for informing the Council of the detailed of the proposed plans, which will be discussed later in the meeting.

104/19 NIGHT SITE FOR "DEVON AIR AMBULANCE" (DAA) – CLLR ALLIS & TOBY RUSSELL COMMUNITY LANDING SITES DEVELOPMENT OFFICER

Mr Russell explained that community landing sites are assessed to ensure there are no hazards. Currently there are 133 operational sites and 80 being assessed.

A 50 x 50 metre area is required for night landing, lighting and the area needs to be near to people. Pedestrian access is also beneficial. The Air Ambulance electronically control the lighting on the site. The playing field in Ermington is large enough, there is access to it and there is no livestock within the site where the helicopter will land.

Cllr Allis and Toby have discussed the playing field area and the costs implications. An electrical supply is being sourced and the cost of the new lighting can be covered by the DAA. The cost to the Parish Council would currently be £2,700 - £2,800. The DAA would consult with the residents who live near the playing field. Work and costings still have to be carried out before the project can be formally submitted to the Parish Council at the January 2020 meeting.

Cllr Onley stated that in principal the Parish Council agreed to the proposal but pointed out that SHDC own the playing field.

Mr Russell stated that the lighting column and the electricity supply would need ownership.

Cllr Onley enquired on the timescale if the proposal was agreed. Mr Russell stated it could take from 6 months to a year to have a site operational.

Cllr Walding suggested involving the Village Fund in the discussion as they host various events in the playing field.

Agreed to discuss the proposal as an agenda item at the January 2020 meeting. ACTION: Clerk
