### An update from County after Storm Bert.

Our flood risk team is working closely with the Environment Agency and District Councils to review the communities and properties in Devon which were flooded during Storm Bert. Strong winds and heavy rain battered Devon last weekend and we received reports that approximately 40 properties suffered internal flooding. The results of the investigation, which will be published in the New Year, will help us identify which properties and areas would most benefit from future resilience measures, in line with other priorities, workload and funding opportunities.

Our initial investigations, which includes feedback from communities, shows that in the communities where we have delivered flood schemes in recent years, such as Ivybridge, Sidmouth, Axminster, Uplyme and Stokeinteignhead, flooding was prevented. The number of flooded properties across the county would certainly have been much higher without these essential flood improvements. In Modbury for instance, approximately 4 million litres of water (4,000 cubic metres) was held behind a specially constructed dam without which many properties would have been flooded. The dam was part of a £1.1million scheme delivered in 2019 and it helps control the flow of water through the drainage system in Modbury town centre by storing excess water behind it and redirecting the flow of water from certain fields.

Councillor Roger Croad, Cabinet Member with responsibility for flood resilience said: "We are committed to implementing measures to reduce flood risk to communities across Devon and we will continue to work to maximise funding to make a real difference to our residents."

Please make sure you have let me know of any areas where homes were flooded so that we make sure not to miss any homes.

### **Devolution Latest**

The 'Devon and Torbay Combined County Authority Regulations 2024", a 'statutory instrument' (SI), has been laid in Parliament, paving the way towards the creation of the Devon and Torbay Combined County Authority. The Regulations will be debated in the House of Commons and the House of Lords. When they are signed by the Secretary of State for Housing, Communities and Local Government, Angela Rayner MP, under powers delegated by the Levelling-up and Regeneration Act 2023, the Devon and Torbay Combined County Authority (CCA) will come into being. The CCA will make decisions about the powers and funding devolved from Whitehall to Devon and Torbay through the deal that was agreed in January this year.

Paul Arnott, Leader of East Devon District Council & Chair of Devon Districts' Forum, said: "This legislation is an important precursor to the establishment of the Combined County Authority for Devon and Torbay. All the District Councils in Devon will continue to work together and with our partners to ensure that the benefits for local communities arising from the transfer of powers and resources are maximised, **including in relation to the forthcoming Devolution White Paper for England."** 

I have put the last bit in bold as it is probably the most relevant part – devolution is not over just because the CCA is being created. This will very much be the first iteration.

I have requested another meeting with Andrea Davis, Cabinet member responsible, to discuss buses. The parishioner who has raised the issue had heard about extra money and was hopeful, I have been informed that the Government metric being used is based on population and deprivation, which is just another way of saying it's for the (usually Labour represented) towns and cities. Case in point in Devon being Plymouth and Exeter, both Labour run.

I have chased Highways for an update on the costings for the A3121 scheme. Still waiting to hear back.

The Store and More – parking. I have managed to broker a provisional arrangement where I can pay (from my County locality) the rent for 3 spaces in the top car park to be available at all times for The Store and More customers (on an annual basis). These spaces would be signed to that effect. More spaces (in the top car park) will also be available on weekends too, but we need to button down the exact licence arrangement. Before I take this any further, does it have PC support? RESOLVED the Council supports this proposal. ACTION: CIIr Thomas

### 2. Disposal of upholstered furniture

From Sunday, only eight of Devon County Council's household waste recycling centres (HWRCs) will accept upholstered furniture for disposal.

It follows the introduction of new requirements from the Environment Agency which require Devon's recycling centres to have segregated facilities to handle Waste Upholstered Domestic Seating (WUDS).

WUDS include sofas, sofa beds, armchairs, recliner chairs, upholstered kitchen and dining room chairs, upholstered garden furniture, stools and foot stools, office chairs, futons, bean bags, floor and sofa cushions.

In the South Hams, the Ivybridge HWRC will accept WUDS. However, the other recycling centres in the South Hams will not.

- d) Road Warden Scheme and maintenance of the speed cameras = CIIr Creese no update
- e) Assessment of Parish Footpaths and update on repairs to FP10 (Honeys Field to the Parish Church) = **Clir Owens** The contractor is ready to commence work on 18 November on FP10 cost of £4,388.11 (excludes VAT). The repair to FP10 has been completed as follows:

Grade of vegetation on either side of path and level in locations of field as agreed on site with Robert and the landowner.

Install 2 x French drains across footpath as per agreed, arisings levelled in agreed locations in field

Install 2 x 110mm perforated pipe and backfill with 40mm clean stone to act as a French drain and pick up surface water

Supply, lay and compact minimal fines sub base as a base layer over the surface of the path, this allows water to run through the hardcore

Supply, lay and compact type 1 sub base as a finished surface

We have used the sub base from Glendenning's Ashburton quarry as this is the nearest quarry to Ermington so reduced our carbon footprint and is in keeping with the local area

Storm Bert certainly tested the path's resilience. I had to dig a few extra gulleys to drain off surface water, but I am pleased that once it had stopped raining the surface of the path was water free.

Dan Kay (Headteacher) is feeling he has made a good start during this term.

The entrance to the Reception area has been redecorated and now makes an inviting entrance to the School. The Church Warden has been in contact with Dan, and next term they are planning visits to the Church to as part of understanding the local history of Ermington.

Dan is keen that the school is involved in the community of the village.
